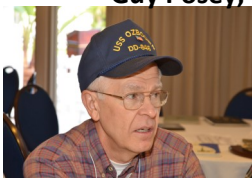

Minutes of the 14th Biennial Reunion Business Meeting

31 August, 2019—Portland, Oregon

At 8:30 AM, 31 August 2019, The business meeting of the USS Ozbourn DD 846 Association was called to order by President Guy Posey with 24 shipmates in attendance. All in attendance joined in the Pledge of Allegiance to our Flag.

The Minutes of the 2017 business meeting in Virginia Beach were read by Recording Secretary Ken Keene. With no additions or correction, a motion was made and seconded to approve the minutes as read; a vote to approve was passed by the majority.

The Treasurers Report was given by Guy Posey in the absence of Treasurer Phil Roberts. The current balance of the Association account on 31 August 2019 was \$20,685.13. This does not include dues collected from shipmates at the reunion or final reunion expenses. With no additions or correction, a motion was made and seconded to approve the Treasurers Report as read; a vote to approve was passed by the majority.

The Fireball Report was also given by Guy Posey in the absence of Corresponding Secretary and Fireball Editor Jeff Parker. The total cost for printing, postage and copies of the 7 editions since the 2017 business meeting was \$1,359.07. The number of newsletters mailed depends on how many members have paid their dues for that year. Generally, there are 150 to 210 copies of the newsletter printed each time. With no additions or correction, a motion was made and seconded to approve the Fireball Report as read; a vote to approve was passed by the majority.

A Report on the 2019 Reunion was given by committee chair Mark Beaulieu. With 32 registrations submitted there was a total of \$11,411.00 collected and expenses prior to the business meeting were \$11,316.56 for a current profit of \$94.36. This amount will change as final bills are submitted to the committee. With no additions or correction, a motion was made and seconded to approve the Reunion Report as read; a vote to approve was passed by the majority.

Old Business

No old business was brought to the floor for discussion.

New Business

Election of Officers:

With the Treasurer, Phil Roberts being the only officer wishing to resign, a call for volunteers and nominations for each office was made. President Guy Posey stated that Mike Ward was willing to accept the nomination for Treasurer. With no other volunteers or nominations for any office, a vote was taken for each position. A motion was made and seconded to accept the slate of; President, Guy Posey. Vice President, Mark Beaulieu. Recording Secretary, Ken Keene. Treasurer, Mike Ward. Corresponding Secretary and Editor, Jeff Parker. A vote to approve the slate of officers till the 2021 business meeting passed by majority.

Minutes of the 14th Biennial Reunion Business Meeting (Cont.)

Donations:

Secretary Ken Keene read Section IV Paragraph E of the Association Bylaws pertaining to donations of the association monies to remind the membership of these guide lines. Mark Beaulieu then reported that three requests for donations were received at least 90 days prior to the meeting and gave a brief description of how our donated money was to be used. They were Tin Can Sailors, Wounded Warrior Project, and Disabled American Veterans. The balance of the Association account 90 days prior to the meeting was \$19,101.43 which allows a maximum total of donations of \$1,910.00. The Association officers recommended that the Tin Can Sailors receive \$550.00, and Wounded Warrior Project and Disabled American Veterans receive \$275.00 each for a total of \$1,100.00 in donations. This is the same amount as was approved for these organizations at the 2017 meeting. A motion was made and seconded to approve the recommended donations, the vote passed by majority.

Member Dr. John Glick inquired about the possibility of a donation to the Destroyer Cassin Young in Boston in the future since it is not supported by Tin Can Sailors. Mark Beaulieu and Ken Keene agreed to re-search the organization and report on our findings at the 2021 meeting for consideration.

Next Reunion:

It was pointed out that in keeping with Section VII, Paragraph B, of the Association Bylaws, that the 2021 reunion should be held in the central part of the country. Volunteers for the Reunion Committee were Mark Beaulieu, Guy Posey, and Harold McKeenan. It was pointed out that the customary expense amount of \$1,000.00 for the reunion committee was not in the Bylaws and needed to be approved at each business meeting. A motion was made and seconded to make available to the reunion committee the amount of \$1,000.00 payable by the Treasurer upon receiving receipts for their expenses. The vote to approve the \$1,000.00 for the reunion committee passed by majority. A brief discussion followed about the benefits of having a large enough group to aid in negotiating a good contract with the hotels and other vendors. A request for recommendations for the location of the next reunion was made and cities such as Milwaukee, Denver, Branson, and Louisville were all mentioned. The reunion committee can research these and other cities to get what they feel is the best deal and location.

With no further new business brought to the floor, a motion was made and seconded to adjourn: Vote to adjourn passed by majority. The 2019 Business Meeting was adjourned by Association President Guy Posey at 9:46 AM.

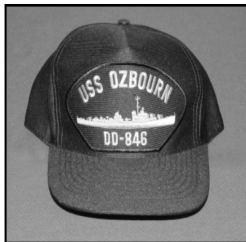

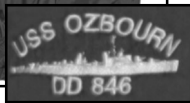

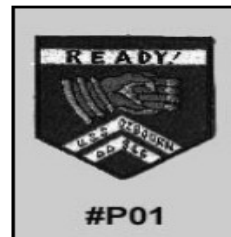
