### SIXTY YEARS AGO TODAY, AUGUST 9, 1965

Shipmate Marty Zipser recalled that on August 9, 1965, the USS Ozbourn DD846, was pier side docked in Nagasaki, Japan on the 20th anniversary of the dropping of the atomic bomb known as "Fat Man" on the City of Nagasaki. Ultimately leading to the unconditional surrender of Japan to end World War II.

Marty reported that no one of the ship's company was permitted to leave the ship. There were peaceful protestors on the pier who chanted and carried signs to ban the bomb. Fortunately, there were no incidents.

**SEPTEMBER 10-13, 2025**

The expense for producing the 14 "Fireball" Newsletters since the 2021 Reunion meeting, totaled \$2,204.50.

A motion was made and seconded to approve the "Fireball" Report. Report approved by majority.

President Guy Posey also announced that Jeff Parker no longer wished to fill the duties of the Corresponding Secretary. After a brief discussion, it was decided to combine the duties of the Corresponding Secretary and the Recording Secretary into one position.

A motion was made and seconded to combine the two positions. Motion passed by majority.

President Guy Posey inquired of the members if they had any old business.

As no old business was brought to the floor, President Guy Posey moved on to the next item.

The amount recommended for this years campaign was a total \$1,000.00, with the following recipients and amounts.

\$250.00 to The Disabled American Veterans (DAV)

Following a brief discussion a motion was made and seconded. Approved by majority.

#### **Reunion Committee Expenses**

Brought to the floor by President Guy Posey.

Currently, the amount of \$1,000.00 is allotted to the Reunion Committee to cover expenses to prepare for our reunions. Guy pointed out that the actual expense to prepare for the 2025 reunion was \$1,057.59.

A short discussion to reimburse the committee the \$57.59 followed. A motion was made and seconded. Approved by majority.

Since expenses have increased in recent years, a discussion continued regarding increasing the allowance for the Reunion Committee to \$1,500.00 for the 2027 Reunion. A motion was made and seconded. Approved by majority.
